

## SQE candidates

Updated March 2025

Here are the steps you need to take before applying for admission as a solicitor of England and Wales. We also offer guidance on when to do this, but the steps do not have to be done in a set order.

You'll also find a personalised SQE checklist within mySRA (in 'My profile') that tracks your progress to admission and highlights next steps.

### Create your accounts - do this first

- Create a mySRA account - this is where you will tell us about your degree, work experience and apply for admission. Find out how to [create an account \[https://guidance.sra.org.uk/mysra/get-mysra-account/#heading\\_a27d\]](https://guidance.sra.org.uk/mysra/get-mysra-account/#heading_a27d).
- Create an SQE assessment account to book your exams and get your results. [Find out how \[https://sqa.sra.org.uk/registering-and-booking/\]](https://sqa.sra.org.uk/registering-and-booking/).
- Please make sure the names match exactly on the two accounts.

### Validate your degree - anytime

- Your degree must be a [UK degree or equivalent level 6 qualification \[https://guidance.sra.org.uk/become-solicitor/sqe/check-validate-qualification/degree-equivalent/\]](https://guidance.sra.org.uk/become-solicitor/sqe/check-validate-qualification/degree-equivalent/) and can be in any subject. - You can also apply for equivalence to a degree using other qualifications (eg CILEX level 3 qualification) and/or relevant work experience. - If you are a solicitor apprentice, your degree or equivalent level 6 qualification will be validated through your SQE assessment account.

### Retrieve SQE assessment results - passed both exams

- You'll need to retrieve your SQE results in mySRA once you have passed all your required assessments. Log into mySRA, and in 'Start a new application' you'll find the 'Retrieve your SQE results' application.



## Register your qualifying work experience - anytime

- You must register two years' [qualifying work experience](https://guidance.sra.org.uk/become-solicitor/sqe/qualifying-work-experience-candidates/) [https://guidance.sra.org.uk/become-solicitor/sqe/qualifying-work-experience-candidates/]. before you can apply for admission Find out more about [recording your work experience](https://guidance.sra.org.uk/become-solicitor/sqe/qualifying-work-experience-candidates/registering-qualifying-work-experience/) [https://guidance.sra.org.uk/become-solicitor/sqe/qualifying-work-experience-candidates/registering-qualifying-work-experience/].
- If you are a solicitor apprentice, this can be any two-year period within your apprenticeship.

## Background checks and suitability - just before applying for admission
