Warning: Websites misusing the details of Blackfriars Law Limited

Websites are operating misusing the details of Blackfriars Law Limited.

What is the scam?

A website for 'Petr Khuan Solicitors LLP' is operating at 'www.petrkhuan solicitorsllp.com' and misusing the details of Blackfriars Law Limited.

A website for 'Kendall & Kelly Lawfirm LLP' is operating at 'www.kandkfirm.com' and also misusing the details of Blackfriars Law Limited.

The above websites appear to have cloned Blackfriars Law Limited's website.

The website 'www.petrkhuan solicitorsllp.com' misuses the names and images of genuine employees at Blackfriars Law Limited including the names of a genuine solicitor, lawyer, conveyancing executive, paralegal and trainee solicitor (see below). It provides an email address of 'info@petrkhuansolicitorsllp.com', telephone numbers of '0739 371 4771' and '0739 371 4000' and an address of 'The McLaren Building, 46 The Priory Queensway, Birmingham, B4 7LR'.

The website 'www.kandkfirm.com' misuses the names of genuine employees at Blackfriars Law Limited including the names of a genuine solicitor, conveyancing executive, paralegal and trainee solicitor (see below). It provides an email address of 'info@kandkfirm.com' and an address of 'The McLaren Building, 46 The Priory Queensway, Birmingham, B4 7LR'.

Both websites misuse the SRA number of a genuine firm of solicitors (see below).

The SRA does not authorise or regulate a firm of solicitors called 'Petr Khuan Solicitors LLP' or 'Kendall & Kelly Lawfirm LLP'

Any business or transaction through the contact details above is not undertaken by a firm or solicitor authorised and regulated by the SRA.

Is there a genuine firm or person?



The SRA authorises and regulates a genuine firm of solicitors called Blackfriars Law Limited with the SRA number 652720. Its postal address is 506 Alum Rock Road, Birmingham, B8 3HX. Its telephone numbers are 0121 247 9491 and 0121 245 2522 and its email address is info@blackfriarslaw.co.uk.

The SRA authorises and regulates the following employees at the genuine firm:

The genuine firm of Blackfriars Law Limited and the above individuals have confirmed that they have no connection to the above websites.

What should I do?

When a firm's or individual's identity has been copied exactly (or cloned), due diligence is necessary. If you receive correspondence claiming to be from the above firm(s) or individual(s), or information of a similar nature to that described, you should conduct your own due diligence by checking the authenticity of the correspondence by contacting the law firm directly by reliable and established means. You can contact the SRA to find out if individuals or firms are regulated and authorised by the SRA and verify an individual's or firm's practising details. Other verification methods, such as checking public records (e.g. telephone directories and company records) may be required in other circumstances.
