1. The [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) shall establish and maintain a fund for making grants in respect of applications made in accordance with these rules.

## **Rule 2: Residual discretion and fund of last resort**

2. The [Fund](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [\[https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) is a discretionary fund of last resort and no [person](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#person) has a right to a grant enforceable at law. The [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) retains a discretion to refuse to consider an application or to make a grant notwithstanding that the conditions in these rules for making a grant are satisfied.
3. The circumstances in which the residual discretion in rule 2.1 may be exercised include, but are not limited to, circumstances in which the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) considers that the loss suffered is not material in all the circumstances or has been appropriately compensated through another means.
4. The [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) may refuse or reduce a grant where the loss or part of the loss is, or was, capable of being made good or appropriately compensated by some other means, including another compensation scheme.

### **Rule 3: Grants which may be made from the Fund**

3. A [person](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#person) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#person] may apply for a grant out of the [Fund](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund], if the loss referred to in rule 3.3 relates to services provided:
  1. by the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] for them; or
  2. to, or as, a [trustee](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#trustee) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#trustee] where they are a beneficiary of the estate or trust.
  
3. A [person](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#person) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#person] who is not a client of the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] may apply for a grant out of the [Fund](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] if they:
  1. were a party on the other side of a legal matter on which the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] was acting; and
  2. have suffered, or are likely to suffer, financial loss in accordance with rule 3.3 arising as a result of the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] failing to apply funds for the purpose intended where they should have been used (whether on completion of certain conditions or otherwise) to complete a transaction for their benefit, or to make a settlement or other payment to them.
  
3. For any grant to be made out of the [Fund](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund], an [applicant](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] must satisfy the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that the [applicant](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] is eligible in accordance with rule 4 and (save in respect of a grant made under rule 3.4) has suffered, or is likely to suffer, financial loss directly resulting from:
  1. the dishonesty of a [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] or the employee or [manager](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#manager] or [owner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#owner) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#owner] of a [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]; or
  2. failure to account for money which has come into the hands of a [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] or the employee or



[manager](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#manager>] or [owner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#owner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#owner>] of a [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>], which may include the failure by a [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] to complete work for which the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] was paid,

in the course of an activity of a kind which is part of the usual business of a [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] and, in the case of a [defaulting licensed body](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-licensed-body) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-licensed-body>], the act or default arose in the course of performance of an activity regulated by the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA>] [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA>] in accordance with the terms of the body's licence.

4. The [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA>] may make a grant to alleviate direct losses suffered as a result of the civil liability of a [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] or a [defaulting practitioner's](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner-s) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner-s>] employee, [manager](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#manager>] or [owner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#owner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#owner>] in circumstances where:
  1. the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] in accordance with the SRA Indemnity Insurance Rules should have had, but did not have, in place a [policy](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#policy) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#policy>] of [qualifying insurance](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance>];
  2. the liability of the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] or the [defaulting practitioner's](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner-s) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner-s>] employee or [manager](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#manager>] would have been covered by a [policy](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#policy) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#policy>] of [qualifying insurance](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance>]; and



3. the loss is not covered by the [SIF](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SIF) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SIF>].
5. No grant will be made under rule 3.4 where due to the insolvency or cessation of the [insurer](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#insurer>], the [defaulting practitioner's policy](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] of [qualifying insurance](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance>] has been disclaimed or otherwise ceases.
6. The [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA>], [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#sra>] may make a grant as an interim measure in relation to part of an application before the application has been fully assessed.

#### **Rule 4: Eligibility for a grant**

4. A [person](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#person) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#person>] is eligible to apply for a grant out of the [Fund](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund>] if, at the time the application is made, they are:
  1. an individual;
  2. a sole trader; [partnership](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#partnership) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#partnership>], body corporate, unincorporated association or mutual association with an annual [turnover](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#turnover) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#turnover>] or [assets](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#asset) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#asset>] of less than £2 million;
  3. a [charity](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#charity) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#charity>] with annual income net of tax in the most recent financial year of less than £2 million; or
  4. a [trustee](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#trustee) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#trustee>] of a trust with an asset value of less than £2 million.
5. The [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA>] may take into account such evidence as it sees fit when determining eligibility under rule 4.1 and may make a broad estimate of any relevant amount.

#### **Rule 5: Defaulting practitioners**

5. A [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [<https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] means:



1. a [solicitor](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor] or an [REL](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#REL) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#REL] who at the date of the relevant act or omission was:
    1. practising in an [authorised body](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]; or
    2. practising in a [non-commercial body](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#non-commercial-body) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#non-commercial-body].;
  2. a [solicitor](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor] or an [REL](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#REL) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#REL] who at the date of the relevant act or omission:
    1. was self-employed and practising in their own name, and not through a trading name or service company;
    2. did not employ anyone in connection with the services they provided; and
    3. was engaged directly by their clients with their fees payable directly to them;
  3. an [RFL](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#RFL) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#RFL] who is a manager or owner of an authorised body;
  4. a [recognised body](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body]; or
  5. a [licensed body](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#licensed-body) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#licensed-body],
- and the expressions "defaulting solicitor", "defaulting REL", "defaulting recognised body", "defaulting RFL" and "defaulting licensed body" shall be construed accordingly.
6. A grant may be made where, at the date of the relevant act or omission:
    1. a [defaulting solicitor](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] had no practising certificate in force;

The [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] shall not make a grant in respect of the act or omission of an [RFL](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#RFL) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#RFL], or the employee of an [RFL](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#RFL) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#RFL], where such act or omission took place outside England and Wales, unless the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] is satisfied that the act or omission was, or was closely connected with, the act or omission of a [solicitor](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor] or the employee of a [solicitor](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor], or that the act or omission was closely connected with practice in England and Wales.

14. Where the loss has been sustained as a result of the act or omission of more than one party, the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] will consider the role of each party in contributing to the [applicant's](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] loss in deciding whether to make a grant and, if so, the amount of any grant.
15. In the case of a [defaulting licensed body](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] will consider the extent to which the loss is attributable to an act or omission which falls outside the performance of an activity regulated by the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] in accordance with the terms of the body's licence in deciding whether to make a grant and, if so, the amount of any grant.

### **Rule 15: Application and time limit**

15. An [applicant](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) must make an application for a grant in the [prescribed](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed) form, and within 12 months of the date they first became aware, or should reasonably have become aware, of the loss.
16. The [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) may extend the 12 month period in rule 15.1 if satisfied that there are circumstances which justify the extension of the time limit.
17. The [applicant](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) must provide information, documents and evidence requested by the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA), which may include verification of matters by statement of truth or affidavit. Failure to provide such documentation or to co-operate with the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) will be taken into account when determining the merits of the application.

### **Rule 16: Notice to defaulting practitioner**

16. The [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) may not make a grant unless it has given not less than 8 days' notice to the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) informing them of the nature and value of the application, unless it appears to the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) that it would not be reasonably practicable to give such notice, or the grant should be made urgently.
17. Where the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) has made a grant urgently in accordance with rule 16.1, the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) shall as soon as, and so long as, it is practicable to do so, give notice to the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) in the terms set out in rule 16.1 and may (insofar as any failure to give notice before the making of the grant has prejudiced the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner).) waive in whole or in part the [Fund's](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) right of recovery under rule 18 against the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner).



## **Rule 17: Recovery and subrogation**

17. Where the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) makes a grant otherwise than by way of loan or if by way of loan repayments of the loan is waived or otherwise the borrower has failed to repay part or all of the loan, the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) shall be subrogated to the rights and remedies of the [person](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#person) to whom or on whose behalf the grant is made to the extent of the amount of the grant.
18. Where rule 17.1 applies, the recipient must if required by the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) whether before or after the grant has been made and upon the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) giving the recipient a sufficient indemnity against costs, prove in any insolvency or winding up of the [defaulting practitioner](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) and sue for recovery of the loss in the name of the recipient but on behalf of the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA).
19. The recipient of a grant must comply with all proper and reasonable requirements of the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) for the purpose of giving effect to the [SRA's](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) rights under this rule, and shall permit the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) to have conduct of any proceedings brought on its behalf.

## **Rule 18: Refusal of an application**

18. If the [SRA](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) refuses to make a grant of either the whole or part of the amount applied for, the [applicant](https://guidance.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) will be informed in writing of the reasons for the decision.
19. The fact that an application has been rejected does not prevent a further application being submitted provided that material new relevant evidence or information is produced in support of the new application.
