Outcome details

This outcome was reached by SRA decision.

Reasons/basis

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which will reach its own decision after considering all the evidence, including any evidence put forward by the Solicitor. The Tribunal has certified that there is a case to answer in respect of allegations which are or include that, whilst in practice as a Sole Practitioner at Grenville Young Solicitor (a recognised sole practice) and/or whilst practising as a Freelance Solicitor:-

1. He failed to co-operate with the SRA's investigations between November 2019 and April 2023.
2. He failed to co-operate with the SRA and its agents during and/or after the SRA's intervention into his practice.

The allegations are subject to a Hearing before the Solicitors Disciplinary Tribunal and are as yet unproven.

Decision details

To intervene into the practice of Grenville Young at Grenville Young Solicitor and into Mr Young's freelance practice.

Reasons/basis

The Panel was satisfied that grounds for intervention existed under paragraph 1(1)(m) of Schedule 1 to the Solicitors Act 1974 (as amended) namely it was necessary to intervene to protect the interests of clients (or former or potential clients) of Mr Young, or the interests of the beneficiaries of any trust which Mr Young is or was a trustee.
