#### **Outcome details**

This outcome was reached by SRA decision.

#### Reasons/basis

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which will reach its own decision after considering all the evidence, including any evidence put forward by the Solicitor. The Tribunal has certified that there is a case to answer in respect of allegations which are or include that Mr Lee:-

- 1. Failed to ensure his firm's books of accounts were properly maintained.
- Failed to obtain new PII cover for his firm from 1 April 2022 onwards, but accepted new instructions from clients and/or continued to act for clients outside of the extended cover periods of the previous policy.
- 3. Provided misleading information to one or more of his clients about his PII position and/or his trading status.
- 4. During an SRA investigation into his work for clients, provided misleading information to the SRA.



The allegations are subject to a Hearing before the Solicitors Disciplinary Tribunal and are as yet unproven.
